M/s Pawan Kumar Sharma, Ward No. 2, Chakradharpur, W. Singhbhum (Distt), Jharkhand, PIN : 833102 was served with a Memorandum and Statement of Imputation of misconduct for Banning of business dealing with them as they have deliberately committed offence involving moral turpitude in relation to business dealings with a view to cheat the Railways and to get undue benefit from Railway by submitting fake Completion certificate against Sr. DEE(OP)/CKP's Tender Notice No. RSO/CKP/Running Room/DPS/451 dated 20.02.08 for the work 'Maintenance of Electric Running Room at DPS (i.e. cooking, serving of meals, security, providing news paper and magazines, up-keeping of lawn/garden, cleaning of buildings and lavatory etc'.

2. In reference to the Memorandum and Statement of Imputations of misconduct, clarification of the firm and the views of South Eastern Railway (SER) which were received vide SER's letter dated 16.06.2022 the Competent Authority on merits of the case, has considered the matter and it is established that M/s. Pawan Kumar Sharma is fully responsible for indulging in the malpractices by supplying fake completion certificate against the above tender. It has, therefore, been decided by the Competent Authority in the Ministry of Railways (Railway Board) that business dealing with M/s Pawan Kumar Sharma, Ward No. 2, Chakradharpur, W. Singhbhum (Distt), Jharkhand, PIN : 833102 and also with their allied/sister concerns & partners should be banned on all Indian Railways including Project Organizations, Production Units and Railway PSUs etc. under the Ministry of Railways (Railway Board) for a period of five (05) years with immediate effect.
