- 1) This is with reference to corresponded cited under reference above.
- 2) In your reply dated 24.03.2023 (cited above at s.no. 7 under reference) to RITES' show cause notice dated 24.02.2023 (cited above at s.no. 6 under reference), you have specifically stated that you did not submit any affidavit mentioning about blacklisting of your firm by any organization. However, you have submitted "Performa-3 declaration by the bidder" with your bid, duly signed, sealed & notarized on an affidavit, wherein relevant point (iv) stipulated as under:

"(iv) No Central/State Government Department/Public Sector Undertaking or Enterprise of Central/State Government has banned/suspended business dealings with us as on date;"

- 3) The above said declaration / affidavit submitted by you, is contrary to your reply dt 24.03.2023, wherein on one hand you have yourself accepted that your firm has been put on holiday list (blacklisted) by M/s NBCC, however, on the other hand you have specifically stated that you did not submit any affidavit mentioning about blacklisting of your firm by any organization.
- 4) Accordingly, the competent authority for banning business as per para 8.3 of "Annexure-A (Guidelines on Banning of Business Dealings) of Integrity Pact of Section-1 at page 57 of technical bid for the subject tender" has found you in violation of provisions of para 6.5 of "Annexure-A (Guidelines on Banning of Business Dealings) of Integrity Pact of Section-1 at page 57 of technical
